Remarks (if any):

1. On 11 December 2014, the Company entered into an agreement with Richfield (Holdings) Limited and Mr. Au Wing Wah, pursuant to which 760,000,000 shares were repurchased by the Company on 27 February 2015, but not yet been cancelled. For details, please refer to the Company's announcements dated 11 December 2014, January 2015, 11 January 2015, the Company's circular dated 11 January 2015 and the Company's supplemental circular dated 30 January 2015.
2. According to the share option scheme of the Company, an option shall lapse automatically on the date the grantee, who is an employee (whether full time or part time, including any executive directors but not any non-executive director) of the Company or any of its subsidiaries ("Eligible Employee"), ceases to be an Eligible Employee. Following the completion of the above-mentioned share repurchase on 27 February 2015, Mr. Au Wing Wah was no longer the Eligible Employee of the Group. Therefore the 8,400,000 share options granted to Mr. Au Wing Wah lapsed automatically on the same day.
